COMMISSION MEMBER ANNOUNCEMENTS

TOWN ATTORNEY - MANDI PORTER

-Ms. Porter had no new business.

PLANNING AND ZONING CONSULTANT - EDMUND CUEMAN

2024 Union Bridge Comprehensive Plan Review

-Mr. Cueman stated that the Town received an extensive letter from Maryland Department of Planning (MDP) concerning the Union Bridge Plan Amendment (Draft Plan). The Commission also received comments from Carroll and Frederick Counties. Mr. Cueman noted all comments will be considered by the Commission prior to the Commission taking action on the Plan Amendment and recommending it to Council for Adoption.

Potomac Edison-Carroll-Mount Airy 230 kv Transmission Line Rebuild Project

-The Town received a letter dated September 23, 2024, from GIA, on the proposed 230 kv transmission line rebuild project. GIA letter seeks any concerns the Commission may have about the project. No information or detail has been provided as to what the replaced structures will look like and what relationship this may have to the Maryland Piedmont Reliability Project (MPRP) proposed 500kv high voltage over head transmission line project. Mr. Cueman recommended that an acknowledgement letter be sent requesting a copy of plan drawings indicating details of the replacement structures before the Commission can detail any concerns and to inquire about the MPRP relationship, if any. Planning and Zoning Commission agreed to Mr. Cueman's recommendation. Mr. Cueman will draft a letter to GIA and Chairman Long will sign it. A copy of GAI's letter and Mr. Cueman's memorandum report is attached to and made a part of these minutes.

CARROLL COUNTY PLANNING LIASON

-No one from Carroll County Planning was in attendance.

PUBLIC COMMENTS AND CONCERNS

-Mr. Will Fries, 4600 Green Valley Road, inquired about the possibility of cannabis growing operations be permitted within the corporate limits of The Town of Union Bridge. The Town Attorney, Mandi Porter informed Mr. Fries that she has been instructed by the Mayor and Council to look into it and she is currently working on it and that if the Town wants to move forward with it, it will involve changing the Town Code and this process will take time.
