THE TOWN OF UNION BRIDGE COUNCIL MEETING MINUTES December 23, 2024

The Council met in the Union Bridge Town Hall, on Monday, December 23, 2024 at 7:00 p.m., for their monthly council meeting. Mayor Jones presided over the meeting with councilmembers Laura Conaway; Ellen Cutsail; Bret Grossnickle; Amy Kalin; Cheri Thompson; Town Attorney, Mandi Porter and Town Attorney John Maguire. Councilmember Ellen Cutsail motioned to approve the November 2024 operating statements; November 25, 2024 council meeting minutes, December 9, 2024 work session minutes and Quantum's financial statements for November 2024. Council President Laura Conaway seconded and the motion passed unanimously.

MAYOR'S REPORT

-Mayor Jones attended the Maryland Municipal League (MML) Carroll County Chapter meeting in Manchester.

ATTORNEY REPORT - JOHN MAGUIRE

-Mr. Maguire discussed Citizens UB Solar, LLC, subdivision water and sewer connections. Mr. Maguire reviewed the Declaration of Private Utility Easements and Maintenance Responsibilities for Future Connections draft. After discussion, Councilmember Bret Grossnickle motioned to accept using this concept as part of the approval process. Councilmember Ellen Cutsail seconded and the motion passed unanimously. CLERK TREASURER - DAWN METCALF

-The WWTP funds that were placed into a US Treasury matured on December 19, 2024. As of December 20, 2024, the current overall balance is \$5,477,037.29 and a six (6) month US Treasury is yielding 3.95% and a one (1) year at 3.9%. After discussion, Council President, Laura Conaway motioned to place the funds into the six (6) month US Treasury yielding 3.95%. Councilmember Ellen Cutsail seconded and the motion passed unanimously.

CARROLL COUNTY SHERIFF'S OFFICE - DEPUTY MCGINNIS

-Deputy McGinnis reported that between November 25, 2024 and December 23, 2024, the Carroll County Sheriff's Office received 47 calls for service within the Town of Union Bridge. Council President, Laura Conaway seconded and the motion passed unanimously.
